- Kohalpur Municipality, Office of Municipal Executive, Kohalpur, Banke has allocated funds from GoN and intends to apply part of the funds to cover eligible payments under the Contract for Srijana Tole ko Nahar Dekhi Bouddha Bihar Hundai 8 no. Ward ko Simana ra Baijanath Gaun Hundai 7 no. Ward Jane Bato Staronnati. (Contract no.: BANKE/KOMUN/W/NCB-01/2081/082). Bidding is open to all eligible bidders as per Section V of bidding document.**
- Kohalpur Municipality invites electronic bids from eligible bidders for the Srijana Tole ko Nahar Dekhi Bouddha Bihar Hundai 8 no. Ward ko Simana ra Baijanath Gaun Hundai 7 no. Ward Jane Bato Staronnati, under National Competitive Bidding– Single Stage Two Envelope Bidding procedures.**

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 4,70,00,000 (Excluding VAT).**
- Minimum Work experience of similar size and nature: **1 single blacktop road construction project with a value of NRs. 1,30,00,000 (Excluding VAT).**
- Minimum construction experience in the following key activities:
  - **Sub-Base Course** - **1827 cum per year.**
  - **Base Course** - **1340 cum per year.**
  - **Asphalt Concrete** - **325 cum per year.**

- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- Electronic bids must be submitted to the **Kohalpur Municipality Office, Kohalpur, Bank** through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 hours** on **2081/07/25**. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hours on 2081/07/25 at Kohalpur Municipality Office**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a scanned copy of the bid security in pdf format amounting to a minimum of **NRs. 9,00,000**, which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
