- 5. Electronic bids must be submitted to the Kohalpur Municipality Office, Kohalpur, Bank through PPMO's website <u>www.bolpatra.</u> gov.np/egp on or before 12:00 hours on 2082/08/16(Dec-02-2025). Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 2082/08/16 (Dec-02-2025) at Kohalpur Municipality Office. Bids must be valid for a period of as specified above after bid opening and must be accompanied by a scanned copy of the bid security in .pdf format, amounting to a minimum of As Specified Above, which shall be valid for 30 days beyond the validity period of the bids.
- 7. Bidders are further required to hire locally available labors as much as possible.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
